



Privacy Policy:

Universal Nexus and C.W. Johnson-Miles values our relationship with you and the other users of our web site (the "Web Site") and the services offered on it (the "Universal Nexus Services"). We recognize that you may be concerned about our collection, use, and disclosure of your personally identifiable information ("Personal Information") that we may collect when you use the Web Site and the Universal Nexus Services. Accordingly, we have implemented this Privacy Policy to inform you of the information that we collect from you, how we collect this information, and what we do with it after we collect it. Accordingly, when you access or use the Web Site or the Universal Nexus Services, you agree that we can collect, use, and disclose your information in accordance with this Privacy Policy. If you do not agree or are not comfortable with any part of this Privacy Policy, you may not use the Web Site or the Universal Nexus Services. We may make changes to the Privacy Policy from time to time.

Personal Information - We collect Personal Information from you. Personal Information is information that can be used to identify you individually, such as your name, mailing address, phone number, and email address. We do not collect credit card numbers and financial information, and we do not collect Non-Personal Information, such as your browser type, the URL of the previous web site you visited, your ISP, operating system, and your IP Address, but third party Internet companies that we work with might collect these items. Generally speaking, we do not intentionally disclose your information to third parties without your consent. In some instances, however, we reserve the right to do so because it is necessary to the operation and continued growth of our business or to protect the rights of others.

We use Personal Information primarily for our own internal purposes, such as providing, maintaining, evaluating, and improving the Universal Nexus Services and the Web Site, fulfilling requests for information, manufacturing and shipping the products that you order, and providing customer support. For example, if you sign up to receive a Universal Nexus newsletter, we will use the email address you provide to send you the newsletters. Whenever we obtain your Personal Information, we use commercially reasonable efforts to protect it from unauthorized access or disclosure. However, we are not insurers of the security of your Personal Information. Accordingly, we assume no liability for any disclosure of data due to errors in transmission, unauthorized third party access or other acts of third parties, or acts or omissions beyond our reasonable control.

You can obtain a copy of and request that we correct errors in your Personal Information by emailing us at freedomexpress64@yahoo.com. For your protection, you will be required to provide proof of your identity to obtain a copy of your Personal Information. If you wish, we will delete all of your Personal Information (except for your transaction history) from our records upon your request. However, if you choose to delete your Personal Information, you may not be able to access some areas of the Web Site or use some of the Universal Nexus Services.

You may be able to access third-party web sites directly from the Web Site. This Privacy Policy does not apply when you access such web sites. We cannot control how third parties may use Personal Information you disclose to them, so you should carefully review the privacy policy of any third-party web site you visit before using it or disclosing your Personal Information to its provider.

The Universal Nexus Services are intended for users ages thirteen and older. Accordingly, we will not knowingly collect or use any Personal Information from children that we know to be under the age of thirteen. In addition, we will delete any information in our database that we know originates from a child under the age of thirteen. Prospective users between the ages of thirteen and seventeen can only use the Universal Nexus Services under their parents' legal guardian's supervision. If you are between the ages of thirteen and seventeen, you, your parent, or your legal guardian may request that we delete any of your Personal Information in our database and/or "opt out" from receiving communications from us.
